

ORDINANCE NO. 95

AN ORDINANCE OF THE PRESIDENT AND BOARD OF TRUSTEES
OF THE NORTHFIELD WOODS SANITARY DISTRICT TO LEVY
A CERTAIN AMOUNT OF MONEY FOR THE FISCAL YEAR
MAY 1, 1980, THROUGH APRIL 30, 1981.

BE IT ORDAINED by the President and Board of Trustees of the
NORTHFIELD WOODS SANITARY DISTRICT, Cook County, Illinois:

Section 1: That for the purpose of defraying all the necessary
expenses and liabilities of the NORTHFIELD WOODS SANITARY DISTRICT, Cook
County, Illinois, for the fiscal year commencing May 1, 1980, and ending
