

ORDINANCE NO. 97

AN ORDINANCE OF THE PRESIDENT AND BOARD OF TRUSTEES
OF THE NORTHFIELD WOODS SANITARY DISTRICT
APPROPRIATING MONEY FOR THE PURPOSE OF DEFRAYING
THE NECESSARY EXPENSES AND LIABILITIES OF THE DISTRICT
FOR THE FISCAL YEAR MAY 1, 1981 TO APRIL 30, 1982

BE IT ORDAINED by the President and Board of Trustees of the
NORTHFIELD WOODS SANITARY DISTRICT, Cook County, Illinois:

Section 1: That for the purpose of defraying all the necessary
expenses and liabilities of the NORTHFIELD WOODS SANITARY DISTRICT, Cook
County, Illinois, for the fiscal year commencing May 1, 1981 and ending
April 30, 1982, the following sums, or so much thereof as by law may be
authorized, be and the same are hereby set aside and appropriated for the
following purposes, to-wit:

Operating Expense of Sewer System	14,000.00
Office Expense	7,200.00
Office Supplies, Stationary, Printing, Postage	400.00
Premium on Bond	100.00
Publication of Legal Notices	400.00
Trustees Fees	<u>9,000.00</u>
TOTAL	\$119,500.00

Section 2: That any unexpended balance of any items of any appropriations made by this ordinance may be expended in making any insufficiency in any other item of appropriation made by this ordinance.


Section 3: That this ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.


