

ORDINANCE NO. 12

AN ORDINANCE AMENDING AN ORDINANCE
PASSED JUNE 27, 1957 ESTABLISHING
CHARGES AND RATES FOR THE USE OF
THE SEWERAGE SYSTEM OF THE NORTH-
FIELD WOODS SANITARY DISTRICT, COOK
COUNTY, ILLINOIS, AND PROVIDING FOR
THE COLLECTION THEREOF

WHEREAS, By Ordinance No. 9 adopted June 27, 1957, the Northfield Woods Sanitary District, Cook County, Illinois, established the rate of Three Dollars and Seventy-Five Cents (\$3.75) per month for each residential dwelling user of the sewerage system of the District and Ten Dollars (\$10.00) per month for each commercial or industrial user of the sewerage system of the District; and

WHEREAS, since the sewer revenue bonds actually issued by the District amounted to \$22,000.00 and the amount needed to repay the principal, interest and other charges applicable to the sewerage revenue bonds is thereby reduced; and

WHEREAS, after a thorough study of the same it is the opinion of the Board of Trustees of the Northfield Woods Sanitary District that the monthly charge for residential dwelling users can be reduced to \$2.50 per month, and the monthly charge for commercial or industrial users can be reduced to \$8.00 per month,

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE NORTHFIELD WOODS SANITARY DISTRICT, COOK COUNTY, ILLINOIS:

Section 1: That so much of Section 1 of an Ordinance entitled:

"AN ORDINANCE Establishing Charges and Rates for the use and service of the sewerage system of the Northfield Woods Sanitary District, Cook County, Illinois; and providing for the collection thereof"

which said Ordinance was adopted on June 27, 1957 as Ordinance No. 9, and in part reads as follows:

"For each residential dwelling user of the sewerage system a service charge of \$3.75 per month shall be made.

"For each commercial or industrial user of the sewerage system a service charge of \$10.00 per month shall be made."

be and the same is hereby amended to read as follows:

"For each residential dwelling user of the sewerage system a service charge of \$2.50 per month shall be made.

"For each commercial or industrial user of the sewerage system a service charge of \$8.00 per month shall be made."

Section 2: That this Ordinance shall be in full force and effect from and after its passage, approval and publication according to law.
