

ORDINANCE NO. 38

AN ORDINANCE OF THE PRESIDENT AND BOARD OF TRUSTEES
OF NORTHFIELD WOODS SANITARY DISTRICT TO LEVY A
CERTAIN AMOUNT OF MONEY FOR FISCAL YEAR MAY 1, 1966
THROUGH APRIL 30, 1967

BE IT ORDAINED by the President and Board of Trustees of
the NORTHFIELD WOODS SANITARY DISTRICT, Cook County, Illinois:

Section 1: That for the purpose of defraying all the
necessary expenses and liabilities of the NORTHFIELD WOODS SANITARY
DISTRICT, Cook County, Illinois, for the fiscal year commencing
