ORDINANCE NO. 39

AN ORDINANCE TO ANNEX CERTAIN TERRITORY TO
THE NORTHFIELD WOODS SANITARY DISTRICT
COOK COUNTY, ILLINOIS.

WHEREAS, the President and Board of Trustees of the Northfield Woods Sanitary District have determined that annexation of certain territory, hereinafter described, is in the best interest of the Northfield Woods Sanitary District and will promote the public health, safety, comfort, morals, and welfare of the Northfield Woods Sanitary District and its residents; and

WHEREAS, the President and Board of Trustees of the Northfield Woods Sanitary District find that such territory, hereinafter described, is contiguous to the Northfield Woods Sanitary District and is dedicated or used for street or highway purposes, and that no part thereof is within any other sanitary district,

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE NORTHFIELD WOODS SANITARY DISTRICT, COOK COUNTY, ILLINOIS:

Section 1: That the following-described territory:

All that portion of Milwaukee Avenue in Sections 19 and 30 of Township 42 North, Range 12 East of the Third Principal Meridian running from the southerly right-of-way line extended of West Lake Avenue to a line approximately 4,620 feet northwesterly thereof, said line being an extension to the southwesterly of the northerly line of Lot 1 in John C. Bornhoff's Subdivision of part of Lots 12 and 22 of the Assessor's Division of the Southwest quarter of Section 19 aforesaid, excluding therefrom those portions of Milwaukee Avenue and West Lake Avenue already included within the territorial boundaries of the Northfield Woods Sanitary District.

ALSO

All that portion of Sanders Road in Sections 19 and 30 aforesaid, running from the northeasterly right-of-way line of Milwaukee Avenue northerly a distance

of approximately 2,639 feet to the north line of the south 1,079 feet of the Southeast quarter of said Section 19, excluding therefrom that portion of Sanders Road which is both Easterly of the center line thereof and northerly of the south 264 feet, as measured on the center line of Sanders Road, of said Section 19, all in Cook County, Illinois;

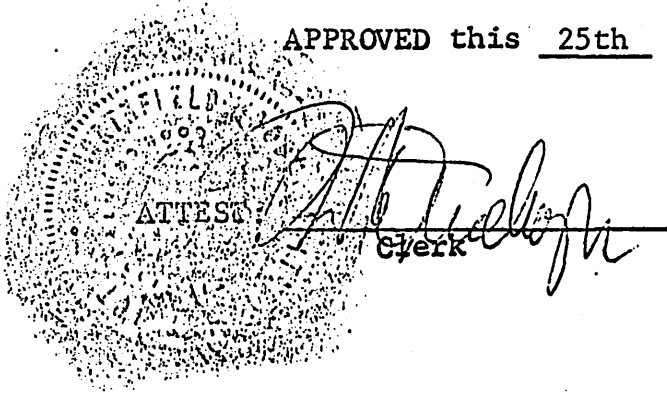
be and the same is hereby annexed to the Northfield Woods Sanitary District, Cook County, Illinois, pursuant to the provisions of Ill. Rev. Stat. 1965, Ch 42, Section 443a2.

Section 2: That this ordinance shall be effective upon its passage and approval according to law.

Section 3: That the attorney for the Northfield Woods Sanitary District is hereby authorized and directed to file with the County Clerk of Cook County a copy of this ordinance with an accurate map of the territory annexed, attached hereto and made a part hereof, certified as correct by the Clerk of the Northfield Woods Sanitary District.

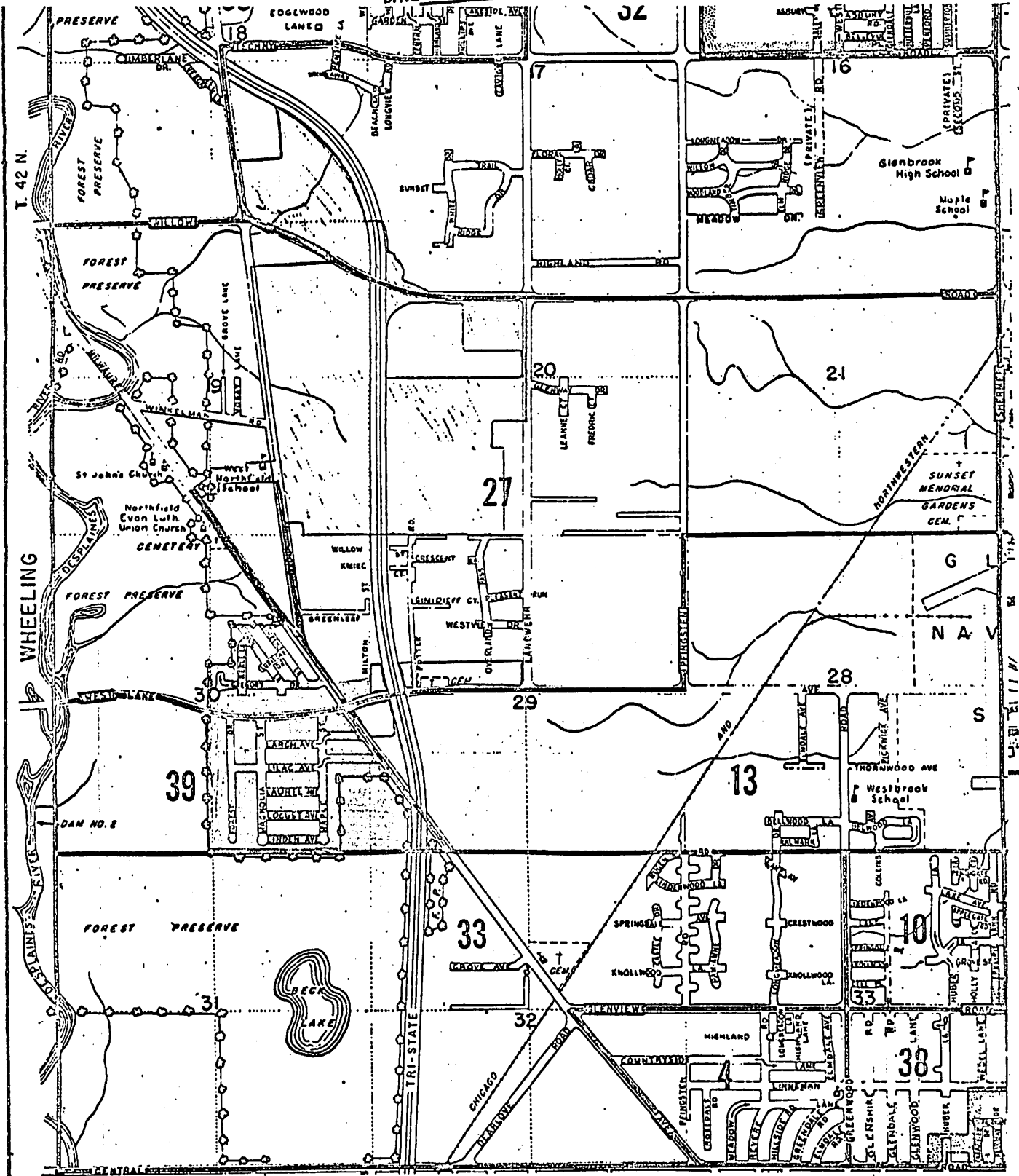


