

ORDINANCE NO. 102

AN ORDINANCE OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE
NORTHFIELD WOODS SANITARY DISTRICT APPROPRIATING MONEY FOR
THE PURPOSE OF DEFRAYING THE NECESSARY EXPENSES AND LIABILITIES
OF THE DISTRICT FOR THE FISCAL YEAR MAY 1, 1982 to April 30, 1983

BE IT ORDAINED by the President and Board of Trustees of the
NORTHFIELD WOODS SANITARY DISTRICT, Cook County, Illinois:

Section 1: That for the purpose of defraying all the necessary
