

ORDINANCE NO. 149

AN ORDINANCE OF THE PRESIDENT AND BOARD OF TRUSTEES  
OF THE NORTHFIELD WOODS SANITARY DISTRICT TO  
LEVY A CERTAIN AMOUNT OF MONEY FOR THE  
FISCAL YEAR MAY 1, 1992, THROUGH APRIL 30, 1993

BE IT ORDAINED by the President and Board of Trustees  
of the NORTHFIELD WOODS SANITARY DISTRICT, Cook County,  
Illinois:

SECTION 1: That for the purpose of defraying all  
the necessary expenses and liabilities of the NORTHFIELD WOODS  
SANITARY DISTRICT, Cook County, Illinois, for the fiscal year  
commencing May 1, 1992, and ending April 30, 1993, a tax for the  
following sums, or so much thereof as by law may be authorized,  
be and the same is hereby levied against all taxable property  
in the NORTHFIELD WOODS SANITARY DISTRICT for the following  
purposes, to-wit:


