

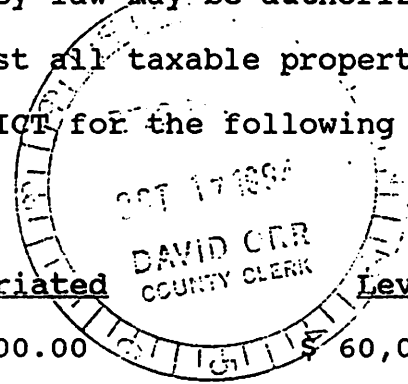
ORDINANCE NO. 156

AN ORDINANCE OF THE PRESIDENT AND BOARD OF TRUSTEES
OF THE NORTHFIELD WOODS SANITARY DISTRICT TO
LEVY A CERTAIN AMOUNT OF MONEY FOR THE
FISCAL YEAR MAY 1, 1994, THROUGH APRIL 30, 1995

BE IT ORDAINED by the President and Board of Trustees

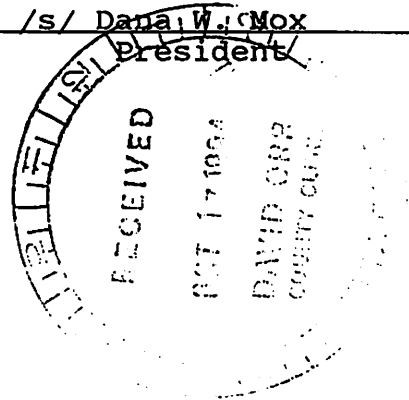

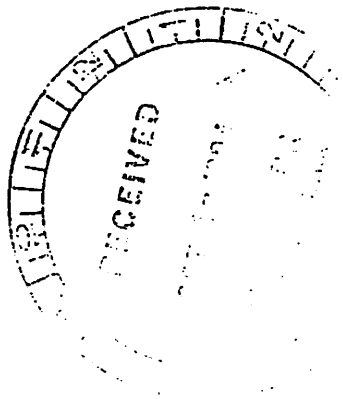

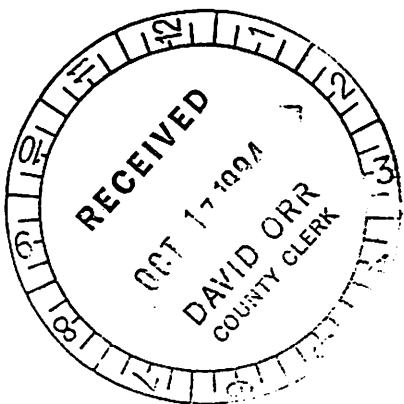
