ORDINANCE NO. 170

**AN ORDINANCE TO ANNEX CERTAIN TERRITORY TO THE
NORTHFIELD WOODS SANITARY DISTRICT,
COOK COUNTY, ILLINOIS**

WHEREAS, a Petition to the Circuit Judge of Cook County, Illinois, County Department - County Division, has been filed with the Circuit Court of Cook County, Illinois, petitioning for the annexation of the property hereinafter described as Parcel 1, legally described on Exhibit "A" attached hereto and made a part hereof; and

WHEREAS, said Petition was signed by the owners of the land constituting such territory who, then and since the time of signing the same, represent all the area of such territory; and

WHEREAS, said Petition was signed by the proper authorities of the Village of Glenview, waiving its statutory protection under 70 ILCS 2805/32a and authorizing said territory to be annexed to the NORTHFIELD WOODS SANITARY DISTRICT; and

WHEREAS, said Petition contains a definite description of the boundaries of such territory as hereinafter described, and sets forth the willingness of the Petitioners that such territory and the taxpayers thereof assume a proportionate share of the bonded indebtedness, if any, of the said NORTHFIELD WOODS SANITARY DISTRICT; and

WHEREAS, pursuant to the order of the Circuit Court of Cook County, Illinois, County Department - County Division, entered February 19, 1998, in Case No. 98 CO 00037, a hearing was scheduled for March 27, 1998, before the Honorable Judge Francis Barth, Judge of the Circuit Court of Cook County, Illinois, County Department - County Division, to consider and determine the boundaries of such proposed addition described as Parcel 1, to be annexed to the NORTHFIELD WOODS SANITARY DISTRICT, and proper public notice of the time and place of such hearing was given in accordance with said order and the statute in such case made and provided; and

WHEREAS, a public hearing was held on March 27, 1998, pursuant to said notice and order, before the Honorable Judge Francis Barth, Judge of the Circuit Court of Cook County, Illinois, County Department - County Division, and said Judge, after said public hearing, fixed and determined the boundaries of such territory described as Parcel 1 to be annexed and entered an order, dated March 27, 1998, containing his findings and decisions as to the boundaries of such territory to be annexed, as more particularly described below; and

WHEREAS, the President and Board of Trustees of the NORTHFIELD WOODS SANITARY DISTRICT have considered the question of annexation of the territory described in said Petition, and Order entered March 27, 1998; and

WHEREAS, the President and Board of Trustees of the NORTHFIELD WOODS SANITARY DISTRICT have independently determined that said territory described in said order of March 27, 1998, is contiguous to the present limits of the NORTHFIELD WOODS SANITARY DISTRICT within the limits of Cook County, Illinois;

NOW, THEREFORE, be it ordained by the President and Board of Trustees of the NORTHFIELD WOODS SANITARY DISTRICT, Cook County, Illinois:

SECTION 1: That the territory described on Exhibit "A" be and the same is hereby annexed as additional territory to the NORTHFIELD WOODS SANITARY DISTRICT, Cook County, Illinois, pursuant to the provisions of 70 ILCS 2805/32a.

SECTION 2: That this Ordinance shall be effective upon its passage and approval according to law.

SECTION 3: That the attorney for NORTHFIELD WOODS SANITARY DISTRICT is hereby authorized and directed to file with the Circuit Judge of Cook County, Illinois, County Department - County Division, a certified copy of this Ordinance, together with a map of the territory to be annexed, attached hereto and made a part hereof.




