**AN ORDINANCE OF THE PRESIDENT AND BOARD OF TRUSTEES  
OF THE NORTHFIELD WOODS SANITARY DISTRICT TO  
LEVY A CERTAIN AMOUNT OF MONEY FOR THE  
FISCAL YEAR MAY 1, 2010, THROUGH APRIL 30, 2011**

**BE IT ORDAINED** by the President and Board of Trustees of the **NORTHFIELD WOODS SANITARY DISTRICT**, Cook County, Illinois:

**NOTICE OF PROPOSED PROPERTY TAX LEVY FOR  
NORTHFIELD WOODS SANITARY DISTRICT**

I. A public hearing to approve a proposed property tax levy for Northfield Woods Sanitary District for the fiscal year May 1, 2010 through April 30, 2011 will be held on Tuesday, November 2, 2010 at 5:00 p.m. at 3633 West Lake Avenue, Suite 403B, Glenview, Illinois.

II. The corporate and special purpose property taxes extended or abated for fiscal year May 1, 2009 through April 30, 2010 were two hundred ninety thousand six hundred thirty dollars (\$290,630.00).

The proposed corporate and special purpose property taxes to be levied for fiscal year May 1, 2010 through April 30, 2011 are two hundred ninety-eight thousand four hundred seventy-seven dollars (\$298,477.00). This represents a two and seven tenths percent (2.7%) increase over the previous year.

III. The property taxes extended for debt service and public building commission leases for fiscal year May 1, 2009 through April 30, 2010 were zero dollars (\$0).

The estimated property taxes to be levied for debt service and public building commission leases for fiscal year May 1, 2010 through April 30, 2011 are zero dollars (\$0).

IV. The total property taxes extended for fiscal year May 1, 2009 through April 30, 2010 were two hundred ninety thousand six hundred thirty dollars (\$290,630.00).

The estimated total property taxes to be levied for fiscal year May 1, 2010 through April 30, 2011 are two hundred ninety-eight thousand four hundred seventy-seven dollars (\$298,477.00). This represents a two and seven tenths percent (2.7%) increase over the previous year.

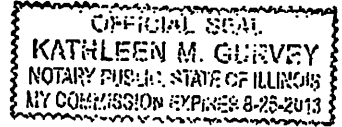




