- I. A public hearing to approve a proposed tax levy for Northfield Woods Sanitary District for the fiscal year May 1, 2011 through April 30, 2012 will be held on Tuesday, December 13, 2011 at 5:00 p.m. at 3633 West Lake Avenue, Suite 403B, Glenview, Illinois. - II. The corporate and special purpose property taxes extended or abated for fiscal year May 1, 2010 through April 30, 2011 were two hundred ninety eight thousand four hundred seventy seven dollars (\$298,477.00).
The proposed corporate and special purpose property taxes to be levied for fiscal year May 1, 2011 through April 30, 2012 are three hundred two thousand nine hundred fifty four dollars (\$302,954.00). This represents a one and five tenths percent (1.5%) increase over the previous year.
- III. The proposed taxes extended for debt service and public build commission leases for fiscal year May 1, 2010 through April 30, 2011 were zero dollars (\$0).
