

ORDINANCE NO. 65

AN ORDINANCE TO AMEND ORDINANCE NO. 63,
ANNUAL APPROPRIATION ORDINANCE, OF THE
NORTHFIELD WOODS SANITARY DISTRICT FOR
FISCAL YEAR MAY 1, 1973 TO APRIL 30, 1974

WHEREAS, subsequent to adoption of Ordinance No. 63, there has arisen a necessity for the expenditure of additional funds to comply with the requirements of the Metropolitan Sanitary District that a sewer atals be supplied and that certain inspections be conducted.

NOW THEREFORE BE IT ORDAINED by the President and Board of Trustees of the Northfield Woods Sanitary District, Cook County, Illinois:

Section 1: That Ordinance No. 63 of the Northfield Woods Sanitary District, entitled: "AN ORDINANCE OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE NORTHFIELD WOODS SANITARY DISTRICT APPROPRIATING MONEY FOR THE PURPOSE OF DEFRAYING THE NECESSARY EXPENSES AND LIABILITIES OF THE DISTRICT FOR THE FISCAL YEAR MAY 1, 1973 TO APRIL 30, 1974," be and the same is hereby amended by deleting Section 1 in its entirety and substituting in lieu thereof the following:

"Section 1: That for the purpose of defraying all the necessary expenses and liabilities of the Northfield Woods Sanitary District, Cook County, Illinois, for the fiscal year commencing May 1, 1973 and ending April 30, 1974, the following sums, or so much thereof as by law may be authorized, be and the same are hereby set aside and appropriated for the following purposes, to-wit:

Fees - District Superintendent	\$3,000.00
Engineering	5,000.00
Inspection Fees	1,500.00
Maintenance of sewer - labor	4,000.00
Maintenance of sewer - material	4,000.00
Operating Expenses - sewer	5,000.00

Collector and bookkeeper	3,000.00
Auditing of books	900.00
Attorney's fees	4,000.00
Trustees' fees	3,000.00
Office expense and telephone	500.00
Office supplies, stationery, postage and printing	150.00
Premium on bond	40.00
Election expenses	100.00
Publication of legal notices	100.00
Reserve for contingencies	<u>600.00</u>
 GRAND TOTAL	 \$34,890.00"

Section 2: That this ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.
