ORDINANCE NO. 71

AN ORDINANCE TO ANNEX CERTAIN TERRITORY TO  
THE NORTHFIELD WOODS SANITARY DISTRICT, COOK  
COUNTY, ILLINOIS

WHEREAS, a petition to the Circuit Judge of Cook County, Illinois, County Department-County Division, has been filed with the Circuit Court of Cook County, Illinois, petitioning for the annexation of the property hereinafter described; and

WHEREAS, said petition was signed by all of the owners of lands constituting such territory, who in the case of natural persons have arrived at lawful age, and represent then and since the time of signing the same, all the area of such territory; and

WHEREAS, said petition contains a definite description of the boundaries of such territory as hereinafter described, and sets forth the willingness of the petitioners that such territory and the taxpayers thereof assume a proportionate share of the bonded indebtedness, if any, of the said Northfield Woods Sanitary District; and

WHEREAS, pursuant to the order of the Circuit Court of Cook County, Illinois, County Department-County Division, entered May 21, 1974 in Cause No. 74 Co 630, two judges of the Circuit Court of Cook County, Illinois, were called as assistants to the Judge of the Circuit Court of Cook County, County Department-County Division, to act as a Board of Commissioners at a hearing on July 10, 1974, to consider and determine the boundaries of such proposed addition to be annexed to the Northfield Woods Sanitary

District, and proper public notice of the time and place of such hearing was given in accord with said order and the statute in such case made and provided; and

WHEREAS, a public hearing was held on July 10, 1974, pursuant to said notice and order, before the Judge of the Circuit Court of Cook County, Illinois, County Department-County Division, and two judges of the Circuit Court of Cook County, acting as such Board of Commissioners pursuant to statute in said case made and provided, and said Board of Commissioners, after said public hearing, fixed and determined the boundaries of such territory to be annexed and entered an order, dated July 10, 1974 containing their findings and decisions as to the boundaries of such territory to be annexed, as more particularly described below; and

WHEREAS, the President and Board of Trustees of the Northfield Woods Sanitary District have considered the question of annexation of the territory described in said petition and order entered July 10, 1974; and

WHEREAS, the President and Board of Trustees of the Northfield Woods Sanitary District have independently determined that said territory described in said order of July 10, 1974, is not within the corporate limits of any city, village or incorporated town, and that it is contiguous to the present limits of the Northfield Woods Sanitary District within the limits of Cook County, Illinois

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE NORTHFIELD WOODS SANITARY DISTRICT, COOK COUNTY, ILLINOIS:

Section 1: That the following described territory:

The South 193.70 feet of that part of Lot 2 of the County Clerk's Division of Section 30, Township 42 North, Range 12 East of the Third Principal Meridian, lying between the Center line of Milwaukee Avenue and the center line of Sanders Road, in Cook County, Illinois, except the easterly 50.0 feet (as measured at right angles to the center line of Sanders Road) of the South 193.70 feet of that part of Lot 2 of the County Clerk's Division of Section 30, Township 42 North, Range 12 East of the Third Principal Meridian, lying between the center line of Milwaukee Avenue and the center line of Sanders Road in Cook County, Illinois. Commonly known as 3355 North Milwaukee, Northbrook, Illinois.

All in Cook County, Illinois.

be and the same is hereby annexed as additional territory to the Northfield Woods Sanitary District, Cook County, Illinois, pursuant to the provisions of Ill. Rev. Stat. 1973, Ch. 42, Section 443a.

Section 2: That this ordinance shall be effective upon its passage and approval according to law.

Section 3: That the attorney for the Northfield Woods Sanitary District is hereby authorized and directed to file with the Circuit Judge of Cook County, Illinois, County Department-County Division, a certified copy of this ordinance, together with a map of the territory annexed, attached hereto and made a part hereof.
