

AN ORDINANCE PERTAINING TO THE AWARD OF  
CONTRACT IN CONNECTION WITH THE CONSTRUCTION OF THE PROPOSED SANITARY SEWER SYSTEM TO BE INSTALLED IN AND FOR THE NORTHFIELD WOODS SANITARY DISTRICT, COOK COUNTY,  
ILLINOIS

WHEREAS, the Board of Trustees of the Northfield Woods Sanitary District, Cook County, Illinois, on the 28th day of February, 1957, adopted a resolution authorizing bids to be received in and for said District pertaining to the construction by the District of a sanitary sewer system; and

WHEREAS, on the following dates and in the following newspapers notice to bidders was published:

Chicago Construction News	March 4, 1957
Chicago American	March 6, 1957
Glenview Announcements	March 7, 1957

and for which proper certificates of publication are on file in the records of said District; and

WHEREAS, in accordance with the notice to bidders heretofore published there was received by the District on March 28, 1957, at a regular meeting thereof, bids in accordance with instructions theretofore given; and

WHEREAS, said bids were opened at the aforesaid regular meeting of the District on March 28, 1957, and have been thereafter reviewed and considered by the Board of Trustees of said District; and

WHEREAS, after considering the various bids received and the qualifications of the respective bidders and the amounts thereof;

NOW, THEREFORE BE IT AND IT IS HEREBY ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE NORTHFIELD WOODS SANITARY DISTRICT That:

1. Said Sanitary District does and hereby awards the contract for the construction of the sanitary sewer system in and for the Northfield Woods Sanitary District in accordance

with the plans and specifications issued by Baxter and Woodman, Civil and Sanitary Engineers, Crystal Lake to:

George D. Hardin Company  
2130 South Michigan Avenue  
Chicago, Illinois

for the furnishing of materials and performance of all work necessary for the construction of said sanitary sewer system in the amount of \$137,297.00, subject to additions and deductions as provided in the proposal submitted by said George D. Hardin Company;

2. That the President of said District be and he is hereby authorized and empowered to sign for and on behalf of said District and the Clerk of said District be and he is hereby authorized to sign and attest for and on behalf of said District an agreement between this District and George D. Hardin Company, Contractor, a copy of which agreement is attached hereto and incorporated herein by reference, and that if and as necessary Trustee Riets, as a member of the Board of Trustees, be and he is hereby authorized and empowered to sign as witness to the signature of the President of said District;

3. That all bid bonds received from the other bidders on March 28, 1957 shall be returned by the Treasurer of the District upon receipt by the Clerk of the District of the signed agreement from George D. Hardin Company;

4. That the Clerk of the District be and he is hereby ordered and directed to give notice of awarding said contract by publishing a notice of award of contract in the Glenview Announcements, the same being a newspaper having a general circulation in said District, said notice to be in substantially the following form:

NOTICE OF AWARD OF CONTRACT

Public notice is hereby given that on April 15, 1957, the President of the Board of Trustees of the Northfield Woods Sanitary District, Cook County, Illinois, did award a contract for the construction of a proposed sanitary sewer system within said District to George D. Hardin Company, 2130 South Michigan Avenue, Chicago, Illinois. The amount of the contract is \$137,297.00.
