

ORDINANCE NO. 18

AN ORDINANCE AMENDING AN ORDINANCE
PASSED JUNE 27, 1957, AS AMENDED,
ESTABLISHING CHARGES AND RATES FOR
THE USE OF THE SEWERAGE SYSTEM OF
THE NORTHFIELD WOODS SANITARY DIS-
TRICT, COOK COUNTY, ILLINOIS, AND
PROVIDING FOR THE COLLECTION
THEREOF

WHEREAS, by Ordinance No. 9 adopted June 27, 1957,
as amended by Ordinance No. 12 adopted September 26,
1957, the Northfield Woods Sanitary District, Cook County,
Illinois, established the rate of Two Dollars and Fifty
Cents (\$2.50) per month for each residential dwelling
user of the sewerage system of the District; and

WHEREAS, since the amount needed to repay the prin-
cipal, interest and other charges applicable to the
sewerage revenue bonds has been reduced; and

WHEREAS, after a thorough study of the same it is
the opinion of the Board of Trustees of the Northfield
Woods Sanitary District that the monthly charge for
residential dwelling users can be reduced to \$1.6666 per
month effective on the first day of April,
1959,

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND
BOARD OF TRUSTEES OF THE NORTHFIELD WOODS SANITARY DIS-
TRICT, COOK COUNTY, ILLINOIS:

Section 1: That Section 1 of an Ordinance
entitled "AN ORDINANCE Establishing Charges and Rates
for the use and service of the sewerage system of
the Northfield Woods Sanitary District, Cook County,
Illinois; and providing for the collection thereof", as
amended, be and the same is hereby amended to and shall

hereafter read as follows:

"Section 1: That there shall be and there are hereby established monthly rates and charges for the use of and the service supplied by the sewerage system of the Northfield Woods Sanitary District, Cook County, Illinois, based upon each user of the sewerage system of said District and such rates and charges are hereby established as follows:

For each residential dwelling user of the sewerage system a service charge of \$1.6666 per month shall be made.

For each commercial or industrial user of the sewerage system a service charge of \$8.00 per month shall be made."

Section 2: That this Ordinance shall be in full force and effect from and after its passage, approval and publication according to law.
