

ORDINANCE NO. 101

AN ORDINANCE TO AMEND SECTION 4.2 OF ORDINANCE NO. 92

WHEREAS, by Ordinance No. 92, adopted December 11, 1979, by the NORTHFIELD WOODS SANITARY DISTRICT, Cook County, Illinois, "an Ordinance requiring the installation and maintenance of grease traps in all commercial and industrial locations within the District; requiring a permit for said installations and a permit fee therefor; requiring inspections thereof and an inspection fee therefor, and establishing penalties for the failure to comply with the provisions of this Ordinance", and

WHEREAS, the Board of Trustees of the NORTHFIELD WOODS SANITARY DISTRICT after considering the development of the District and the actual fees and expenses involved in the inspections of grease traps installed pursuant to the aforementioned Ordinance No. 92, and upon recommendation of the District's Treasurer believe that it is in the public interest to amend the aforesaid Section 4.2 of Ordinance No. 92;

NOW THEREFORE, be it ordained by the President of the Board of Trustees of the NORTHFIELD WOODS SANITARY DISTRICT, Cook County, Illinois:

Section 1: That Section 4.2 of Ordinance No. 92, adopted December 11, 1979, and as amended by Ordinance No. 96, adopted July 14, 1980, and as further amended by Ordinance No. 100, adopted November 9, 1981, be and the same is hereby amended to and shall hereafter read as follows:

"Section 4.2. Every person, firm, corporation or other legal entity issued a permit pursuant to this Ordinance shall, commencing twelve (12) months from the date of approval of the installation of said grease trap, pay to the Sanitary District an annual fee in the amount of \$150.00. The fee provided for herein is to cover the cost to the District of the necessary continuing supervision, inspection and regulation of said grease trap installation."

Section 2: That this Ordinance shall be in full force and effect from and after its passage, approval and publication according to law.
