WHEREAS, a Petition to the Circuit Judge of Cook County, Illinois
County Department - County Division, has been filed with the Circuit Court of
Cook County, Illinois, petitioning for the annexation of the property
hereinafter described as Parcel A; and

WHEREAS, said Petition was signed by the owners of the lands constituting such territory, who represent then and since the time of signing the same, all the area of such territory; and

WHEREAS, said Petition contains a definite description of the boundaries of such territory as hereinafter described, and sets forth the willingness of the petitioners that such territory and the taxpayers thereof assume a proportionate share of the bonded indebtedness, if any, of the said NORTHFIELD WOODS SANITARY DISTRICT; and
