

ORDINANCE NO. 141

AN ORDINANCE OF THE PRESIDENT AND BOARD OF TRUSTEES  
OF THE NORTHFIELD WOODS SANITARY DISTRICT  
AMENDING ORDINANCE NO. 140, AN ORDINANCE  
APPROPRIATING MONEY FOR THE PURPOSE OF DEFRAYING  
THE NECESSARY EXPENSES AND LIABILITIES OF THE DISTRICT  
FOR THE FISCAL YEAR MAY 1, 1990, TO APRIL 30, 1991

BE IT ORDAINED by the President and Board of Trustees  
of the NORTHFIELD WOODS SANITARY DISTRICT, Cook County,  
Illinois:

SECTION 1: That for the purpose of defraying all  
the necessary expenses and liabilities of the NORTHFIELD WOODS  
SANITARY DISTRICT, Cook County, Illinois, for the fiscal year  
commencing May 1, 1990, and ending April 30, 1991, the following
