

ORDINANCE NO. 176

**AN ORDINANCE OF THE PRESIDENT AND BOARD OF TRUSTEES
OF THE NORTHFIELD WOODS SANITARY DISTRICT TO
LEVY A CERTAIN AMOUNT OF MONEY FOR THE
FISCAL YEAR MAY 1, 1998, THROUGH APRIL 30, 1999**


