**ORDINANCE NO. 182**

**AN ORDINANCE TO ANNEX CERTAIN TERRITORY TO THE  
NORTHFIELD WOODS SANITARY DISTRICT,  
COOK COUNTY, ILLINOIS**

WHEREAS, a Petition to the Circuit Judge of Cook County, Illinois, County Department - County Division, has been filed with the Circuit Court of Cook County, Illinois, petitioning for the annexation of the property hereinafter described as “The Property”, legally described on Exhibit “A” attached hereto and made a part hereof; and

WHEREAS, said Petition was signed by the owners of the land constituting such territory who, then and since the time of signing the same, represent all the area of such territory; and

WHEREAS, said Petition was signed by the proper authorities of the Village of Glenview, waiving its statutory protection under 70 ILCS 2805/32a and authorizing said territory to be annexed to the NORTHFIELD WOODS SANITARY DISTRICT; and

WHEREAS, said Petition contains a definite description of the boundaries of such territory as hereinafter described, and sets forth the willingness of the Petitioners that such territory and the taxpayers thereof assume a proportionate share of the bonded indebtedness, if any, of the said NORTHFIELD WOODS SANITARY DISTRICT; and

WHEREAS, pursuant to the order of the Circuit Court of Cook County, Illinois, County Department - County Division, entered May 19, 1999, in Case No. 99 CO 083, a hearing was scheduled for June 17, 1999, before the Honorable Judge Francis Barth, Judge of the Circuit Court of Cook County, Illinois, County Department - County Division, to consider and determine the boundaries of such proposed addition, to be annexed to the NORTHFIELD WOODS SANITARY DISTRICT, and proper public notice of the time and place of such hearing was given in accordance with said order and the statute in such case made and provided; and

WHEREAS, a public hearing was held on June 17, 1999, pursuant to said notice and order, before the Honorable Judge Francis Barth, Judge of the Circuit Court of Cook County, Illinois, County Department - County Division, and said Judge, after said public hearing, fixed and determined the boundaries of such territory described as The Property to be annexed and entered an order, dated June 17, 1999, containing his findings and decisions as to the boundaries of such territory to be annexed, as more particularly described below; and

WHEREAS, the President and Board of Trustees of the NORTHFIELD WOODS SANITARY DISTRICT have considered the question of annexation of the territory described in said Petition, and Order entered June 17, 1999; and

WHEREAS, the President and Board of Trustees of the NORTHFIELD WOODS SANITARY DISTRICT have independently determined that said territory described in said order of June 17, 1999, is contiguous to the present limits of the NORTHFIELD WOODS SANITARY DISTRICT within the limits of Cook County, Illinois;

NOW, THEREFORE, be it ordained by the President and Board of Trustees of the NORTHFIELD WOODS SANITARY DISTRICT, Cook County, Illinois:





## **EXHIBIT A**

### **Parcel 1:**

That part of the Southeast ¼ of Section 29, Township 42 North, Range 12, East of the Third Principal Meridian, bounded and described as follows: Beginning at the Northwest corner of said Southeast ¼, thence South along the West line thereof, 669.34 feet; thence North 79 Degrees no Minutes East, 300.52 Feet, thence North 612.59 Feet to the North line of said South East ¼; thence South 89 Degrees 53 Minutes West along said North line, 295 Feet to the place of beginning, excepting therefrom that part taken for roads or highways situated in the Northfield Township, County of Cook, in Illinois; and excepting therefrom the following described property which is hereinafter referred to as "Excepted Parcel". That part of the Southeast ¼ of Section 29, Township 42 North, Range 12, East of the Third Principal Meridian, bounded and described as follows: Beginning at the Northwest corner of said Southeast ¼ thence South along the West line thereof, 669.34 Feet; thence North 79 Degrees 0 Minutes East 300.52 Feet, thence North 187.59 Feet to the point of beginning, thence West 147.50 feet, thence North 200 Feet, thence East 147.50 Feet, thence South 200 feet to the point of beginning.

### **Parcel 2:**

That part of the South East ¼ of Section 29, Township 42 North, Range 12, East of the Third Principal Meridian bounded and described as follows: Beginning at North West corner of said South East ¼ thence South along West line thereof 669.34 Feet thence North 79 degrees 0 Minutes East 300.52 Feet thence North 187.59 Feet for a point of beginning thence West 147.50 Feet thence North 200 Feet thence East 147.50 Feet; thence South 200 feet to the point of beginning.
