**ORDINANCE NO. 184**

**AN ORDINANCE TO ANNEX CERTAIN TERRITORY TO THE  
NORTHFIELD WOODS SANITARY DISTRICT,  
COOK COUNTY, ILLINOIS**

WHEREAS, the President and Board of Trustees of the Northfield Woods Sanitary District have determined that annexation of certain territory, hereinafter legally described on Exhibit A attached hereto and made a part hereof and colored green, with the existing District boundaries shaded in red on Exhibit B attached hereto and made a part hereof, is in the best interest of the Northfield Woods Sanitary District and will promote the public health, safety, comfort, morals, and welfare of the Northfield Woods Sanitary District and its residents; and

WHEREAS, Illinois Compiled Statutes Chapter 70, Section 2805/32a.2 authorizes the annexation by a sanitary district of any territory contiguous to a sanitary district which is used for street or highway purposes if no part of the annexed territory is within any other sanitary district; and

WHEREAS, the President and Board of Trustees of the Northfield Woods Sanitary District have determined that such territory, hereinafter legally described on the attached Exhibit A and colored in green, with the existing District boundaries shaded in red on the attached

Exhibit B, is contiguous to the Northfield Woods Sanitary District and is dedicated or used for street or highway purposes, and that no part thereof is within any other sanitary district.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE NORTHFIELD WOODS SANITARY DISTRICT, COOK COUNTY, ILLINOIS:

SECTION 1: That the territory legally described in Exhibit A attached hereto and made a part hereof and colored green, with the existing District boundaries shaded in red on the annexation map attached hereto as Exhibit B, be and the same is hereby annexed to the Northfield Woods Sanitary District, Cook County, Illinois, pursuant to the provisions of Illinois Compiled Statutes, Chapter 70, Section 2805/32a.2.

SECTION 2: That this Ordinance shall be effective upon its passage and approval according to law.

SECTION 3: That the attorney for the Northfield Woods Sanitary District is hereby authorized and directed to file with the County Clerk of Cook County a copy of this Ordinance with an accurate map of the territory annexed, attached hereto and made a part hereof, certified as correct by the Clerk of the Northfield Woods Sanitary District.

## EXHIBIT A

The West Half (50.00 Feet measured at right angles) of Sanders Road lying South of a line 119.00 Feet South of and parallel with the North line of the Southeast Quarter of Section 19 Township 42 North, Range 12 East of the Third Principal Meridian and lying North of a line 425.00 Feet South and parallel with the North line of the Southeast Quarter aforesaid, in Cook County, Illinois.

Commonly known as part of Sanders Road.

All of Sanders Road in the Southeast Quarter of Section 18, Township 42 North, Range 12, East of the Third Principal Meridian, lying Southerly of the Southwesterly line of the Northern Illinois Toll Road (except that part previously annexed to the Northfield Woods Sanitary District) in Cook County, Illinois.

ALSO

All of Sanders Road in the Northeast Quarter of Section 19, Township 42 North, Range 12 East of the Third Principal Meridian, lying North of the following described line: beginning at a point in the Easterly line of Sanders Road, 196.48 Feet Southerly of an angle point in said Easterly line; thence Westerly parallel with the North line of said Northeast Quarter to the Westerly line of Sanders Road (except that part previously annexed to the Northfield Woods Sanitary District) in Cook County, Illinois

Commonly known as part of Sanders Road.

All that part of Landwehr Road and Willow Road in Section 20, Township 42 North, Range 12, East of the Third Principal Meridian, lying South of the Westerly extension of the North line of Lot 1 in M. Sullivan Toohey's Will-O-Land Estates in the Northeast Quarter of Section 20 aforesaid (except that part previously annexed to the Northfield Woods Sanitary District) in Cook County, Illinois

ALSO

That part of Willow Road and Landwehr Road in Section 20, Township 42 North, Range 12, East of the Third Principal Meridian, described as follows: beginning at a point in the North line of Lot 1 in M. Sullivan Toohey's Will-O-Land Estates in the Northeast Quarter of Section 20 aforesaid, 30.0 Feet East of the Northwest corner of said Lot 1; thence North 100 feet to a point in the North line of Willow Road 80.0 feet East of the West line of the Northeast Quarter of Section 20; thence Northwesterly 42.33 Feet., more or less, to a point in the East line of Landwehr Road 30.0 Feet North of the North line of Willow Road; thence West 50.0 Feet to the West line of the Northeast Quarter of Section 20; thence South along said West line to the Westerly extension of the North line of Lot 1; thence East along said North line and its Westerly extension 80.0 Feet to the point of beginning, in Cook County, Illinois.

Commonly known as part of Landwehr and Willow Roads.
