**ORDINANCE NO. 192**

**AN ORDINANCE TO ANNEX CERTAIN TERRITORY TO THE  
NORTHFIELD WOODS SANITARY DISTRICT,  
COOK COUNTY, ILLINOIS**

WHEREAS, the President and Board of Trustees of the Northfield Woods Sanitary District have determined that annexation of certain territory, hereinafter legally described on Exhibit A attached hereto and made a part hereof, and colored green, with the existing District boundaries shaded in red on Exhibit B attached hereto and made a part hereof, is in the best interest of the Northfield Woods Sanitary District and will promote the public health, safety, comfort, morals, and welfare of the Northfield Woods Sanitary District and its residents; and

WHEREAS, Illinois Compiled Statues, Chapter 70 Section 2805/32a.4 authorizes the annexation by a sanitary district of territory which is not within the corporate limits of the sanitary district, but which is contiguous to it and is served by the sanitary district; and

WHEREAS, the President and Board of Trustees of the Northfield Woods Sanitary District have determined that such territory, hereinafter legally described on the attached Exhibit A and colored in green, with the existing District boundaries shaded in red on the attached Exhibit B, is not within the corporate limits of the sanitary district, is contiguous to the sanitary district and is served by the sanitary district.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE NORTHFIELD WOODS SANITARY DISTRICT, COOK COUNTY, ILLINOIS:

SECTION 1: That the territory legally described on Exhibit A attached hereto and made a part hereof and colored green, with the existing District boundaries shaded in red on the annexation map attached hereto as Exhibit B, be and the same is hereby annexed to the Northfield Woods Sanitary District, Cook County, Illinois, pursuant to the provisions of Illinois Compiled Statutes, Chapter 70, Section 2805/32a.4.

SECTION 2: That this Ordinance shall be effective upon its passage and approval according to law.

SECTION 3: That the attorney for the Northfield Woods Sanitary District is hereby authorized and directed to file with the County Clerk of Cook County a copy of this Ordinance with an accurate map of the territory annexed, attached hereto and made a part hereof, certified as correct by the Clerk of the Northfield Woods Sanitary District.

## EXHIBIT A

That part of Lots 6 to 10 and part of Indian Ridge Drive in Indian Ridge being a subdivision in the West Half of Section 20, Township 42 North, Range 12, East of the Third Principal Meridian, described as follows: beginning at the Southwest corner of Lot 5 in Brookdale Manor Unit No. 3, a subdivision of part of the South 33.0 acres of the Northwest Quarter of said Section 20; Thence South along the Southerly extension of the West line of Lot 5 aforesaid 66.0 feet; Thence Easterly parallel with the South line of Lot 5 aforesaid 177.74 feet to a point of curve; Thence Easterly along an arc of a circle convex Northerly with a radius of 599.79 feet for a distance of 53.06 feet to the East line of Lot 9 in Indian Ridge aforesaid; Thence Northerly along the East line of Lots 8 and 9 in said Indian Ridge, 66.40 feet to the South line of Lot 5 in Brookdale Manor Unit No. 3 aforesaid; Thence Westerly along said South line of Lot 5 for a distance of 229.01 feet to the point of beginning, in Cook County, Illinois
