Early in the 2002 NFL season, quarterback Trent Dilfer had his streak of consecutive winning starts snapped at 15, the fourth longest in the league since 1950. Who holds the top spot? The answer is Jim McMahon, with 25. Like Dilfer, McMahon did it over more than one season. The number two spot is held by San Francisco's Joe Montana with 17 over two seasons, followed by the Raider's Kenny Stabler with 16 over two seasons. By the way, the quarterback with the most consecutive wins beginning with his first game as a starter is Mike Tomczak with 10 for Chicago during the 1986-87 seasons.

Greatest NBA player of all time? Most say Michael Jordan. But consider this. Hall-of-Famer Oscar Robertson actually averaged a triple double every game for an entire season! In 1961-62, "The Big O" averaged 30.5 points, 12.5 rebounds and 11.4 assists with the then Cincinnati Royals. And that was no fluke. He missed doing it again during the 1963-64 season because he averaged "only" 9.9 rebounds. In fact, over his first five seasons, he never averaged less than 29.2 points, 9.5 assists and 9 rebounds per game.

When rookie Rick Nash of the Columbus Blue Jackets scored a goal against Montreal in his first game of the 2002-03 season, it marked the fifth time in NHL history that a player chosen first overall in the draft scored on his first NHL game. Nash joined some very select company. The other four to do it were Mario Lemieux (1984), Pierre Turgeon (1987), Mike Modano (1989) and Eric Lindros (1992).


