**AN ORDINANCE OF THE PRESIDENT AND BOARD OF TRUSTEES

Academy the day before but bounced back to win the tournament finale 7-5 over Sandburg Saturday.

In the next game during preliminary pool competition at the Wilmette Park District ice rink Friday morning, Glenbrook South stunned New Trier Green by taking a 3-1 lead into the second intermission.

P.J. Eagle, who returned to high school hockey this winter after playing with a AA Midget team based in Rolling Meadows last season, provided all the offense. He notched a natural hat trick in the second period.

But the Trevians, who were held to only seven shots on goal in the first two periods, came roaring back in the third, scoring three unanswered goals to win 4-3.

New Trier Green and Fenwick went on to win their pools and their semifinals before matching up in the final. Green won the championship 4-0.

"We played great defense in the first couple periods, but we couldn't hold on," Titan coach Jim Philbin said. "Last year we took a lot of kids young up to the varsity level. They knew they were in a developmental period and they are still in that developmental period now. But we're getting closer and closer."

The Titans, who knocked off

with a power play goal about eight minutes later.

After taking a pass fro Matt Kurz, Luft fired a shot through the five-hole. Glenbrook North goalie P.J. Bonato appeared to be screened on the play.

Glenbrook North retook the lead in the third period on a power play goal of its own. Sonny Barrish scored that one unassisted.

Then, shortly after the clock ticked under two minutes remaining, Glenbrook South found a way to tie it up again.

Kurz secured possession to start the scoring play and passed to Luft.

The senior defenseman skated the puck across the blue line and then down the side of the offensive zone.

Just before he would have been knocked off the puck, Luft sent it into the goal mouth.

The puck deflected a couple of times and then dribbled toward Matt Drew, who was stationed on the far side and then managed to flip it in.

"We just told the guys to throw it toward the net and (Drew) was right where we wanted him to be," Philbin said. "And he knocked it in thank God."
