

ORDINANCE NO. 211

**AN ORDINANCE OF THE PRESIDENT AND BOARD OF TRUSTEES
OF THE NORTHFIELD WOODS SANITARY DISTRICT TO
LEVY A CERTAIN AMOUNT OF MONEY FOR THE
FISCAL YEAR MAY 1, 2007, THROUGH APRIL 30, 2008**

BE IT ORDAINED by the President and Board of Trustees of the **NORTHFIELD WOODS SANITARY DISTRICT**, Cook County, Illinois:

SECTION 1: That for the purpose of defraying all the necessary expenses and liabilities of the **NORTHFIELD WOODS SANITARY DISTRICT**, Cook County, Illinois, for the fiscal year commencing May 1, 2007, and ending April 30, 2008, a tax for the following sums, or so much thereof as by law may be authorized, be and the same is hereby levied against all taxable property in the **NORTHFIELD WOODS SANITARY DISTRICT** for the following purposes, to-wit:




