

ORDINANCE NO. 217

**AN ORDINANCE OF THE PRESIDENT AND BOARD OF TRUSTEES OF
THE NORTHFIELD WOODS SANITARY DISTRICT, COOK COUNTY, ILLINOIS,
AMENDING ORDINANCE NO. 213, 101 AND 92 RELATED TO FEES FOR GREASE
TRAPS**

WHEREAS, Ordinance Number 92 was adopted December 11, 1979, by the NORTHFIELD WOOD SANITARY DISTRICT, (hereinafter referred to as the "District"), Cook County, Illinois and entitled "An Ordinance Requiring The Installation And Maintenance Of Grease Traps In All Commercial And Industrial Locations Within The District; Requiring A Permit For Said Installations And A Permit Fee Therefore; Requiring Inspections Thereof And An Inspection Fee Therefore; And Establishing Penalties For The Failure To Comply With The Provisions Of This Ordinance"; and

WHEREAS, Ordinance Number 92 requires annual inspections of all grease traps at all commercial and industrial uses within the District and established fees for said inspection; and

WHEREAS, Ordinance Number 101, adopted November 9, 1981 and entitled "An Ordinance To Amend Section 4.2 Of Ordinance No. 92" increased the annual grease trap inspection fee from \$50 to \$150; and

WHEREAS, the District has determined that it is most cost-effective to retain an independent contractor to conduct such inspections; and

WHEREAS, the cost of such inspections has risen steadily over the years, although the President and Board of Trustees of the District still believe the cost to be reasonable; and

WHEREAS, Ordinance Number 213, adopted May 6, 2008 and entitled "An Ordinance Of The President And Board Of Trustees Of The Northfield Woods Sanitary District, Cook County, Illinois, Amending Ordinance No. 101 Related To Fees For Grease Traps" increased the annual grease trap inspection fee from \$150 to \$275; and

WHEREAS, since that time, the District Trustees have re-examined all costs of the District and successfully negotiated reduced rates for numerous grease trap related expenses; and

WHEREAS, the President and Board of Trustees, after considering the further development of the District and the actual fees and expenses involved in the inspections of grease traps installed pursuant to Ordinance No. 213, and upon recommendation of the District's Treasurer, believe that it is in the public interest to amend Ordinance No. 213, amending Ordinance No. 101, amending Section 4.2 of Ordinance No. 92; and

NOW THEREFORE, be it ordained by the President and Board of Trustees of Northfield Woods Sanitary District, Cook County, Illinois:

Section 1: That Section 4.2 of Ordinance No. 92, adopted December 11, 1979, and as amended by Ordinance No. 96, adopted July 14, 1980, and as further amended by Ordinance No. 100, adopted November 9, 1981 and as further amended by Ordinance No. 101 adopted November 9, 1981, and as further amended by Ordinance No. 213 adopted May 6, 2008, be and the same is hereby amended to and shall hereafter read as follows:

“Section 4.2. Every person, firm, corporation or other legal entity issued a permit pursuant to this Ordinance shall, commencing twelve (12) months from the date of approval of the installation of said grease trap, pay to the District an annual fee in the amount of \$200.00. The fee provided for herein is to cover the cost to the District of the necessary continuing supervision, inspection and regulation of said grease trap installation.”

Section 2: That this Ordinance shall be in full force and effect from and after its passage, approval and publication according to law.




