**ORDINANCE NO. 199**

**AN ORDINANCE TO ANNEX CERTAIN TERRITORY TO THE  
NORTHFIELD WOODS SANITARY DISTRICT,  
COOK COUNTY, ILLINOIS**

WHEREAS, a Petition to the Presiding Judge of the County Department - County Division of the Circuit Court of Cook County, has been filed, petitioning for the annexation of the property hereinafter described on Exhibit "A", attached hereto and made a part hereof; and

WHEREAS, said Petition was signed by the owners of the land constituting such territory who, then and since the time of signing the same, represent all the area of such territory; and

WHEREAS, said Petition contains a definite description of the boundaries of such territory as hereinafter described, and sets forth the willingness of the Petitioners that such territory and the taxpayers thereof assume a proportionate share of the bonded indebtedness, if any, of the said NORTHFIELD WOODS SANITARY DISTRICT; and

WHEREAS, pursuant to the Petition filed with the Circuit Court of Cook County, Illinois, County Department - County Division, in Case No. 02 CX 004, a hearing was held on December 9, 2002, before the Honorable Judge Michael J. Murphy, Judge of the Circuit Court of Cook County, Illinois, County Department - County Division, to consider and determine the

boundaries of such proposed addition described on Exhibit "A", attached hereto and made a part hereof, to be annexed to the NORTHFIELD WOODS SANITARY DISTRICT, and proper public notice of the time and place of such hearing was given in accord with said Petition and the statute in such case made and provided; and

WHEREAS, a public hearing was held on December 9, 2002, pursuant to said notice and order, before the Honorable Judge Michael J. Murphy, Judge of the Circuit Court of Cook County, Illinois, County Department - County Division, and said Judge, after said public hearing, fixed and determined the boundaries of such territory described on Exhibit "A", attached hereto and made a part hereof, to be annexed and entered an order, dated December 9, 2002, containing his findings and decisions as to the boundaries of such territory to be annexed, as more particularly described below; and

WHEREAS, the President and Board of Trustees of the NORTHFIELD WOODS SANITARY DISTRICT have considered the question of annexation of the territory described in said Petition, and Order entered December 9, 2002; and

WHEREAS, the President and Board of Trustees of the NORTHFIELD WOODS SANITARY DISTRICT have independently determined that said territory described in said order dated December 9, 2002, is not within the corporate limits of any city, village or incorporated town, and that it is contiguous to the present limits of the NORTHFIELD WOODS SANITARY DISTRICT within the limits of Cook County, Illinois;

NOW, THEREFORE, be it ordained by the President and Board of Trustees of the NORTHFIELD WOODS SANITARY DISTRICT, Cook County, Illinois:

SECTION 1: That the territory described on Exhibit "A", attached hereto and made a part hereof, be and the same is hereby annexed as additional territory to the NORTHFIELD

WOODS SANITARY DISTRICT, Cook County, Illinois, pursuant to the provisions of 70 ILCS 2805/32a.

**SECTION 2:** That this Ordinance shall be effective upon its passage and approval according to law.

**SECTION 3:** That the attorney for NORTHFIELD WOODS SANITARY DISTRICT is hereby authorized and directed to file with the Circuit Judge of Cook County, Illinois, County Department - County Division, a certified copy of this Ordinance, together with a map of the territory annexed, attached hereto and made a part hereof.



## EXHIBIT "A"

That part of Lot 24 described as follows: Beginning at a point on the South line of Lot 24 a distance of 102.00 feet West of the Southeast corner thereof, thence Northeasterly 227.00 feet more or less to a point on the Northerly line of said lot, 100.00 feet chord measure Northwesterly of the Northeast corner thereof, thence Northwesterly along the Northerly line of Lot 24, a distance 20.00 feet chord measure thence Southwesterly 55.0 feet more or less to a point 35.0 feet Northwesterly of and measured at right angles to the 227.0 feet line previously mentioned said 35.00 foot dimension being measured from a point on the 227.00 feet line previously measured, 50.00 feet (as measured along said 227.00 foot line) Southwesterly of the Northerly line of Lot 24, thence Southerly 181.00 feet to the point of beginning all in Brookdale Manor Unit #3, being a subdivision of part of the South 33 acres of the Northwest Quarter of Section 20, Township 42 North, Range 12, East of the Third Principal Meridian, in Cook County, Illinois. Also, that part of Lot 24 lying Easterly of a line drawn from a point on the South line of Lot 24, a distance of 102.00 feet west of the Southeast corner thereof to a point on the Northerly line of said Lot 100.00 feet chord measure Northwesterly of the Northeast corner thereof. All in Brookdale Unit #3 being a subdivision of part of the South 33 acres of the Northwest Quarter of Section 20, Township 42 North, Range 12 East of the Third Principal Meridian, in Cook County, Illinois.
