Four Hundred Thirty-One Thousand, Nine Hundred Thirty-Seven (\$431,937.00) DOLLARS.


SECTION 2: This Ordinance shall be in full force and effect from and after its



The property taxes extended for debt service and public building commission leases for fiscal year May 1, 2023 through April 30, 2024, were Zero (\$0) Dollars.





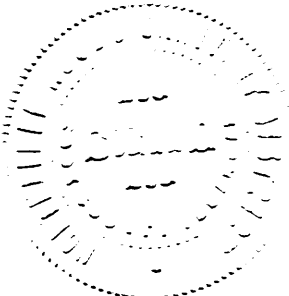
